Dear Assemblyman Paul Anderson:

Under the Nevada Open Records Act § 239 et seq., NRS 293.124, 294A.3, NAC 294A.040, NAC 294A.041, CHAPTER 294A - CAMPAIGN PRACTICES, we are requesting an opportunity to inspect or obtain copies of public records consisting of the following items listed on your 2016 Contributions and Expense Report Annual Report file stamped January 15, 2016 (see attached exhibit A) by the Nevada Secretary of State:

- All receipts for moneys paid directly to Paul Anderson totaling \$5,147.77
- Copies of all monthly credit billing statements for the Visa Black Card with payments totaling \$17,905.84

- Copies of all monthly credit card statements for the Capital One Card with payments totaling \$23,181.50
- A list of point's rewards for both credit cards listed herein paid with campaign funds and records of what was purchased with the points acquired.

We have attached a copy of Mr. Anderson's C&E report filed January 15, 2016 with the items we are requesting highlighted.

If there are any fees for searching or copying these records, please inform us if the cost will exceed \$100.00. However, I would also like to request a waiver of all fees in that the disclosure of the requested information is in the public interest and will contribute significantly to the public's understanding of Nevada finance laws and rules. NEWSMAXTV LAS VEGAS is requesting the information to help the public understand the process.

If access to the records NEWSMAXTV LAS VEGAS is requesting will take longer than a 'reasonable' amount of time, please contact us with information about when we might expect copies or the ability to inspect the requested records.

NEWSMAXTV LAS VEGAS will take legal action to compel the information if Mr. Anderson fails to provide the requested public records within 10 business days from the day of the certified mailing.

If you deny any or all of this request, please cite each specific exemption you feel justifies the refusal to release the information and notify me of the appeal procedures available to me under the law.

Legal Notes:

NAC 294A.040 *General reporting requirements. (NRS 293.124, 294A.380)*

1. *Any contribution received or campaign expense incurred or paid on a candidate's behalf by his or her campaign committee, by his or her personal representative, or by any other authorized person during a period for which a report is required must be reported as the candidate's contribution or campaign expense.*

2. *Reporting requirements are not removed by special circumstances.*

NAC 294A.041 *Use of personal funds of candidate; contributions from members of family of candidate. (NRS 293.124, 294A.380)*

1. *The use of personal funds of a candidate for campaign expenses shall be deemed contributions to his or her campaign that:*

(a) Are not subject to any limits; and

(b) Must be properly reported.

2. *A contribution to a candidate for any office from a member of the family of the candidate is subject to the same limits and reporting requirements set forth in chapter 294A of NRS that apply to any other contribution.*
